The 2022 operating budget is increasing by 4.8% over the 2021 budget. There are no significant changes to the overall budget from the prior year.

There are no major variances from the proposed budget that are in excess of 10% that require additional information or documentation. The main changes were in repairs & maintenance which is being reduced due to the disposition of 2 fire trucks which were the main cause of the this category being high in the prior year. We expect R&M to be reduced as a result. Also, uniforms and personal equipment is expected to increase due to the number of per diems that require fire gear in the 2022 year. We are also purchasing water rescue equipment which we found to be necessary due to the Hurricane IDA which flooded the city of Lambertville.
